1. The date and venue of the Written (Skill) Test will be notified in due course.
2. All provisionally eligible candidates are required to bring a Govt. approved valid photo ID Card for appearing in the Written (Skill) Test.
3. Provisionally Eligible Candidates for whom the “Remarks” column in **Table 2** specifies documents required for appear in the Written (Skill) Test are directed to submit the relevant documents to the Executive Secretary, NASI, Prayagraj – 211002, either by post or via e-mail at es@nasi.ac.in, **on or before October 17, 2025, by 6:00 PM** in support of their candidature. **Failure to submit the required documents will result in denial of permission to appear for the Written (Skill) Test.**
4. Candidates who wish to contest their ineligibility may submit a written representation along with all supporting documents to the Executive Secretary, NASI, Prayagraj – 211002, or via e-mail at es@nasi.ac.in, on or before **October 17, 2025, by 6:00 PM**. Requests received after the stipulated date and time will not be considered.  
After submission and scrutiny of documents, if any candidate is found eligible, they will be informed accordingly. The decision of NASI in this regard will be final, and no further correspondence will be entertained.
5. In case of any inadvertent error in the selection process, which may be detected at any stage, even after issuance of the appointment order, the Academy reserves the right to modify, withdraw, or cancel any communication made to the candidate.
6. Candidates are advised to visit the Academy website (www.nasi.org.in) regularly for further updates.
7. E-mails regarding the Written (Skill) Test to provisionally eligible candidates will be sent separately.
